# ASYMPTOTIC STABILITY AND BLOW-UP OF SOLUTIONS FOR AN EDGE-DEGENERATE WAVE EQUATION WITH SINGULAR POTENTIALS AND SEVERAL NONLINEAR SOURCE TERMS OF DIFFERENT SIGN

#### Abstract

We study the initial boundary value problem of an edge-degenerate wave equation. The operator $\Delta_{\mathbb{E}}$ with edge degeneracy on the boundary $\partial E$ was investigated in the literature. We give the invariant sets and the vacuum isolating behavior of solutions by introducing a family of potential wells. We prove that the solution is global in time and exponentially decays when the initial energy satisfies $E(0) \leq d$ and $I\left(u_{0}\right)>0$. Moreover, we obtain the result of blow-up with initial energy $E(0) \leq d$ and $I\left(u_{0}\right)<0$, and give a lower bound for the blow-up time $T^{*}$.


## 1. Introduction

We consider the following initial-boundary value problem of an edge-degenerate wave equation with singular potentials and several nonlinear source terms of different sign:

where $u_{0} \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E}), u_{1} \in \mathcal{L}_{2}(\mathbb{E}) \cap \mathcal{L}_{2}\left(Q_{T}\right), Q_{T}=\mathbb{E} \times[0, T], T \in(0, \infty)$ and $N=1+n+h \geq 3, a_{k}>0$ for $1 \leq k \leq l, b_{j}>0$ for $1 \leq j \leq s, p_{k}$ and $q_{j}$ satisfy

and $V$ is a positive potential function which can be unbounded on the edge manifold $\mathbb{E}$. Here, $X$ is a closed compact $C^{\infty}$-smooth submanifold of dimension $n$ embedded in the unit sphere of $\mathbb{R}^{n+1}$ and $Y$ is a bounded subset in $\mathbb{R}^{h}$ containing the origin. Write $\mathbb{E}=[0,1) \times X \times Y$, which can be regarded as the local model near the

[^0]boundary of stretched edge-manifolds. Denote $\mathbb{E}_{0}$ for the interior of $\mathbb{E}$, and the boundary of $\mathbb{E}$ by $\partial \mathbb{E}=0 \times X \times Y$. The edge-Laplacian operator is defined as

\Delta_{\mathbb{E}}=\nabla_{\mathbb{E}}^{2}=\left(\omega \partial_{\omega}\right)^{2}+\partial_{x_{1}}^{2}+\ldots+\partial_{x_{n}}^{2}+\left(\omega \partial_{y_{1}}\right)^{2}+\ldots+\left(\omega \partial_{y_{h}}\right)^{2}

where $\nabla_{\mathbb{E}}=\left(\omega \partial_{\omega}, \partial_{x_{1}}, \ldots, \partial_{x_{n}}, \omega \partial_{y_{1}}, \ldots, \omega \partial_{y_{h}}\right)$ denotes the gradient operator with edge degeneracy on the boundary $\partial \mathbb{E}$. Moreover, the degenerate elliptic operator $\Delta_{\mathbb{E}}$ is regarded as a spacial case of type degenerate differential operators on a stretched edge manifold.

In the case of edge degenerate, Chen and Liu 3] considered the following initialboundary value problem for semi-linear parabolic equations with singular potential term:

and derived a threshold of the existence of global solutions with exponential decay and the blow-up in finite time, with low initial energy case and critical initial energy case. Chen et al. 6] first established the corresponding Sobolev inequality and Poincaré inequality on the cone Sobolev spaces, and then proved the existence of non-trivial weak solution for the following Dirichlet boundary value problem for a class of non-linear elliptic equation on manifolds with conical singularities:

Here $\mathbb{B}=[0,1) \times X$ and $X$ is an $(n-1)$-dimensional closed compact manifold. The local model $\mathbb{B}$ is regarded as the local model near the conical points, and $\partial \mathbb{B}=\{0\} \times X$. Moreover, the operator $\Delta_{\mathbb{B}}$ in the above equation is defined by $\left(x_{1} \partial_{x_{1}}\right)^{2}+\partial_{x_{2}}^{2}+\cdots+\partial_{x_{n}}^{2}$, which is an elliptic operator with conical degeneration on the boundary $x_{1}=0$, and corresponding gradient operator is denoted by $\nabla_{\mathbb{B}}=$ $\left(x_{1} \partial_{x_{1}}, \partial_{x_{2}}, \ldots, \partial_{x_{n}}\right)$. Alimohammady et al. I[1] applied the family of potential wells to the following initial boundary value problem of semilinear hyperbolic equations on the cone Sobolev spaces:

u(t, x)=0 \quad \text { on } \partial \mathbb{B} \times(0, T),
\end{gathered}

They not only gave some results of existence and nonexistence of global solutions, but also obtained the vacuum isolating of solutions and showed blow-up in finite time of solutions on a manifold with conical singularities. For different problems which take into account degenerate spaces, we refer to [2, 4, 55, 14].

For a more general problem, Jiang [10] considered equation

\end{equation*}

with initial data

\phi(0, x)=\phi_{0}(x), \quad \phi_{t}(0, x)=\phi_{1}(x) \quad \text { in } \mathbb{R}^{N}

where $1<p \leq \frac{N}{N-2}$ for $N>2(p>1, N=1,2)$. He established new stable and unstable sets for the initial data, and proved that the solution blows up in finite time
when the evolution enters into the unstable set and the solution is global existence when the evolution enters into the stable set. For the case of linear damping and potential terms, Levine [13] showed that the solution of 1.2 with negative initial energy blows up for the abstract version. Zhou [20] proved that the solution of 1.2 with the intial data $\left(\phi_{0}, \phi_{1}\right)$ satisfies $\int_{\mathbb{R}^{N}} \phi_{0} \phi_{1} \geq 0$ and $V(x)=0$ blows up in finite time even for vanishing initial energy. Jiang and Zhang [11] considered the Cauchy problem of a nonlinear wave equation with damping and source terms. When the term works as the damping in the case $m=1$, the equation is equivalent to the problem $(1.2$ with the case $V(x)=0$. Galakhov in [7] discussed the semilinear wave equation with a potential, which is different from 1.2 because of the damping term. For more papers related to the semi-linear hyperbolic problem, you can refer to [8, 12, 18] and the references therein. Liu and Xu [16] studied the following initial boundary value problem of wave equations and reaction-diffusion equations with several nonlinear source terms of different sign:

with initial boundary conditions

\end{gathered}

The authors introduced a family of potential wells and corresponding outside sets and who also proved the invariance of some sets under the flow of the equation and vacuum isolating of solutions. Then, they got the threshold result of existence and nonexistence of global solution.

Motivated by the above results, in this paper, we intend to study the initial boundary value problem for an edge-degenerate wave equation. We consider the existence of global solution by Faedo-Galerkin approximation method 19 and discuss the blow-up of solutions by means of a a convexity argument [15]. The main difficulty in carrying out this paper is considering the problem with singular potentials in an edge type Sobolev space. We introduce stable and unstable sets and construct some functionals. By giving a family of potential wells, we obtain vacuum isolating of solutions. Then we derive a threshold of the existence of global solutions with exponential decay if the initial data are in the stable set, otherwise, we obtain the blow-up result.

The remaining part of our paper is organized as follows. In Section 2, we give some notation and basic facts which are needed for our work. In Section 3, we introduce a family of potential wells, and give the invariance of some sets under the flow of problem 1.1 and the vacuum isolating behavior of the problem. The existence of global solutions and exponential decay result are given in Section 4 . In Section 5, we discuss the blow-up in finite time of solution and seek a lower bound for the blow-up time $T^{*}$.

## 2. Edge type Sobolev spaces

In this section, we introduce some definitions and propositions which will be used in this paper. Now, we recall the Edge type weighted $p$-Sobolev space 3.

Definition 2.1. For $(\omega, x, y) \in \mathbb{R}_{+}^{N}$ with $N=n+h+1$, assume $(\omega, x, y) \in \mathcal{D}^{\prime}\left(\mathbb{R}_{+}^{N}\right)$, we say that $u(\omega, x, y) \in \mathcal{L}_{p}\left(\mathbb{R}_{+}^{N}, d \sigma\right)$ if

where $d \sigma=\frac{d \omega}{\omega} d x_{1} \ldots d x_{n} \frac{d y_{1}}{\omega} \ldots \frac{d y_{h}}{\omega}$. Moreover, the weighted $\mathcal{L}_{p}$ spaces with weight $\gamma \in R$ is denoted by $\mathcal{L}_{p}^{\gamma}\left(\mathbb{R}_{+}^{N}, d \sigma\right)$, which consists of functions $u(\omega, x, y)$ such that

Definition 2.2. For $m \in N, \gamma \in \mathbb{R}$ and $N=n+h+1$, the spaces $\mathcal{H}_{p}^{m, \gamma}\left(\mathbb{R}_{+}^{N}\right)$ is defined by

for $k \in N$, multi-index $\alpha \in N^{n}, \beta \in N^{q}$ with $k+|\alpha|+|\beta| \leq m$. Therefore, $\mathcal{H}_{p}^{m, \gamma}\left(\mathbb{R}_{+}^{N}\right)$ is a Banach space with the following norm:

Moreover, the subspace $\mathcal{H}_{p, 0}^{m, \gamma}\left(\mathbb{R}_{+}^{N}\right)$ of $\mathcal{H}_{p}^{m, \gamma}\left(\mathbb{R}_{+}^{N}\right)$ denotes the closure of $C_{0}^{\infty}\left(\mathbb{R}_{+}^{N}\right)$ in $\mathcal{H}_{p}^{m, \gamma}\left(\mathbb{R}_{+}^{N}\right)$.

If $u \in \mathcal{L}_{p}^{\frac{n+1}{p}}(\mathbb{E})$ and $v \in \mathcal{L}_{p^{\prime}}^{\frac{n+1}{p^{\prime}}}(\mathbb{E})$, where $p, p^{\prime} \in(1, \infty)$ and $\frac{1}{p}+\frac{1}{p^{\prime}}=1$, then we have the following edge type Hölder inequality:

For $t \in(0, T)$, we introduce the energy functional

& -\sum_{k=1}^{l} \frac{a_{k}}{p_{k}+1} \int_{\mathbb{E}} \omega^{h}\left|u_{0}\right|^{p_{k}+1} d \sigma+\sum_{j=1}^{s} \frac{b_{j}}{q_{j}+1} \int_{\mathbb{E}} \omega^{h}\left|u_{0}\right|^{q_{j}+1} d \sigma

An elementary calculation shows

Here, $J(u), I(u)$ and $I_{\delta}(u)$ are well-defined and belong to $C^{1}\left(\mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E}), \mathbb{R}\right)$. Then, we introduce the potential well

To facilitate our calculations, we state the following propositions.
Proposition 2.3 ([3]). For $1<l<2^{*}=\frac{2 N}{N-2}$, the embedding $\mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E}) \hookrightarrow$ $\mathcal{H}_{l, 0}^{1, \frac{n+1}{l}}(\mathbb{E})=\mathcal{L}_{l}^{\frac{n+1}{l}}(\mathbb{E})$ is compact.

Proposition 2.4 (Edge type Poincaré inequality [3]). Let $\mathbb{E} \subset[0,1) \times X \times Y$ be a bounded subset in $\mathbb{R}_{+}^{N}$ with $N=1+n+h$. If $u(\omega, x, y) \in \mathcal{H}_{p, 0}^{m, \gamma}\left(\mathbb{R}_{+}^{N}\right)$ for $1<p<+\infty, \gamma \in \mathbb{R}_{+}$, then

where $d_{\mathbb{E}}$ is the diameter of $\mathbb{E}$.
Proposition 2.5 (Edge type Hardy's inequality [3]). For all $u \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})$,

Next, we give some preparatory work, so that there are some lemmas which will be used in this paper.
Lemma 2.6 (Sobolev-Poincaré 3]). Assume that $u \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})$ and that $\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})} \neq 0$. If $1<p<2^{*}-1=\frac{N+2}{N-2}$ and $N=n+h+1 \geq 3$, then there exist a constant $C_{*}$ such that

C_{j}=\sup \left\{\frac{\|u\| \mathcal{L}_{\mathcal{L}_{j}+1}^{\frac{n+1}{q_{j}+1}}(\mathbb{E})}{\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}}(\mathbb{E})} ; u \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})\right\} .
\end{gathered}

## 3. Invariant sets and vacuum isolating

In this section, we shall introduce a family of Nehari functionals in edge type Sobolev spaces and the family of potential wells sets. Now, we give the corresponding lemmas, which will help us to demonstrate the invariant sets and the vacuum isolating behavior of solutions for the problem.
3.1. Properties of potential wells. In this subsection, we introduce a family of potential wells and give a series of their properties which are used to prove of our main results.
Lemma 3.1. Assume that $u \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})$ and that $\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})} \neq 0$, we have
(1) $\lim _{\lambda \rightarrow 0} J(\lambda u)=0$, and $\lim _{\lambda \rightarrow+\infty} J(\lambda u)=-\infty$;
(2) In the interval $0<\lambda<\infty$, there is a unique $\lambda^{*}=\lambda^{*}(u)>0$, such that $\frac{d}{d \lambda} J\left(\lambda^{*} u\right)=0 ;$
(3) $J(\lambda u)$ is increasing on $0 \leq \lambda<\lambda^{*}$, decreasing on $\lambda>\lambda^{*}$ and takes the maximum at $\lambda=\lambda^{*}$;
(4) $I(\lambda u)>0$ for $0<\lambda<\lambda^{*}, I(\lambda u)<0$ for $\lambda^{*}<\lambda<\infty$ and $I\left(\lambda^{*} u\right)=0$.

Proof. (1) From the definition of $J(u)$, we know that

which gives $\lim _{\lambda \rightarrow 0} J(\lambda u)=0$, and $\lim _{\lambda \rightarrow+\infty} J(\lambda u)=-\infty$.
(2) An easy calculation shows that

& =: \lambda^{p-1} g^{*}(\lambda)
\end{aligned}

Note that $g^{*}(\lambda)$ is increasing on $0<\lambda<\infty$, and that $\lim _{\lambda \rightarrow 0^{+}} g^{*}(\lambda)=-\infty$, $\lim _{\lambda \rightarrow+\infty} g^{*}(\lambda)=+\infty$. Hence there exists a unique $\lambda_{0}>0$ such that $g^{*}\left(\lambda_{0}\right)=0$, therefore $g\left(\lambda_{0}\right)=0, g(\lambda)<0$ for $0<\lambda<\lambda_{0}, g(\lambda)>0$ for $\lambda_{0}<\lambda<\infty$ and $g(\lambda)$ is increasing on $\lambda_{0}<\lambda<\infty$. Hence for any $\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}{ }_{(\mathbb{E})} \geq 0 \text {, there exists a unique }}$ $\lambda^{*}>\lambda_{0}$ such that

In particular, if $0<\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \leq \gamma^{2}(1)$, then $I(u)>0$, where $\gamma(\delta)$ is the unique real root of equation $\varphi(\gamma)=\delta$, and

In particular, if $I_{\delta}(u)>0$, then $\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma>\gamma^{2}(1)$.
Proof. From $I_{\delta}(u)<0$, we have

which implies $\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma>\gamma^{2}(\delta)$.

Theorem 3.5. The function of $\delta, d(\delta)$ possesses the following properties:
(1) $d(\delta)>a(\delta) \gamma^{2}(\delta)$ for $0<\delta<\frac{(p+1)\left(1+C^{* 2}\right)}{2}$ where $a(\delta)=\frac{1}{2}\left(1+C^{* 2}\right)-\frac{\delta}{p+1}$.
(2) $\lim _{\delta \rightarrow 0} d(\delta)>0$ and there exists a unique $\delta_{0}>\frac{(p+1)\left(1+C^{* 2}\right)}{2}$ such that $d\left(\delta_{0}\right)=0$ and $d(\delta)>0$ for $0 \leq \delta<\delta_{0}$.
(3) $d(\delta)$ is increasing on $0 \leq \delta \leq 1$, decreasing on $1 \leq \delta \leq \delta_{0}$ and takes the maximum $d=d(1)$ at $\delta=1$.

Proof. & -\frac{1}{p+1}\left(\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}+1} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}+1} d \sigma\right)
\end{aligned}

& =\left(\frac{1}{2}\left(1+C^{* 2}\right)-\frac{\delta}{p+1}\right) \int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\frac{1}{p+1} I_{\delta}(u) \\
& =a(\delta) \int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma>a(\delta) \gamma^{2}(\delta)
\end{aligned}

= & \frac{1}{2}\left(1+C^{* 2}\right) \int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\frac{p-q}{(p+1)(q+1)} \sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}+1} d \sigma \\
= & \frac{1}{2}\left(1+C^{* 2}\right) \int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\frac{p-q}{(p+1)(q+1)} \sum_{k=1}^{l} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}+1} d \sigma
\end{aligned}

Next, we prove that $d(0)>0$. Let

The fact that $J(u) \geq J_{1}(u)$ for $u \in \mathcal{N}_{0}$ implies $d(0) \geq$ $d_{1}(0)$. In what follows, we prove $d_{1}(0)>0$. Let

Next, for any $u \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E}), \int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \neq 0$

3.2. Characteristics of solutions. In this subsection, we state the invariance of some sets under the flow of 1.1 and the vacuum isolating behavior of problem (1.1).

Definition 3.7 (Maximal existence time). Let $u(t)$ be a weak solution of problem (1.1). We define the maximal existence time $T_{\max }$ of $u(t)$ as follows:
(1) If $u(t)$ exists for $0 \leq t<\infty$, then $T_{\max }=+\infty$.
(2) If there exists a $t_{0} \in(0, \infty)$ such that $u(t)$ exists for $0 \leq t<t_{0}$, but doesn't exist at $t=t_{0}$, then $T_{\max }=t_{0}$.

Now, we discuss the invariance of some sets corresponding to problem (1.1).
Theorem 3.8. Let $u_{0} \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})$, $u_{1} \in \mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})$, and $0<e<d, \delta_{1}<\delta_{2}$ are two roots of equation $d(\delta)=e$. Then:
(1) All weak solutions of problem 1.1 with $0<J\left(u_{0}\right) \leq e$ belong to $W_{\delta}$ for $\delta_{1}<\delta<\delta_{2}, 0 \leq t<T_{\max }$, provided $I\left(u_{0}\right)>0$ or $\left\|\nabla_{\mathbb{E}} u_{0}\right\|_{L_{2}^{\frac{n+1}{2}}{ }_{(\mathbb{E})}=0 . . . ~}^{\text {. }}=0$
(2) All weak solutions of problem (1.1) with $0<J\left(u_{0}\right) \leq e$ belong to $V_{\delta}$ for $\delta_{1}<\delta<\delta_{2}, 0 \leq t<T_{\max }$, provided $I\left(u_{0}\right)<0$,
where $T_{\max }$ is the maximal existence time of $u(t)$.

Arguing by contradiction, by time continuity of $I(u)$ we suppose that there must exist a $\delta_{0} \in\left(\delta_{1}, \delta_{2}\right)$ and $t_{0} \in\left(0, T_{\max }\right)$ such that $u\left(t_{0}\right) \in \partial V_{\delta_{0}}$, and $I_{\delta_{0}}\left(u\left(t_{0}\right)\right)=0$ or $J\left(u\left(t_{0}\right)\right)=d\left(\delta_{0}\right)$. By (3.4) we can see that $J\left(u\left(t_{0}\right)\right) \neq d\left(\delta_{0}\right)$. Let $u(t)$ be any weak solution of problem with $J\left(u_{0}\right)<0$ or $J\left(u_{0}\right)=0$ and $\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \neq 0, T_{\max }$ is the maximal existence time of $u(t)$. Then Theorem 3.10 gives

Then, letting $\delta \rightarrow \frac{(p+1)\left(1+C^{* 2}\right)}{2}$, we obtain $\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \geq \gamma^{2}\left(\frac{(p+1)\left(1+C^{* 2}\right)}{2}\right)$ for $0 \leq t<T_{\max }$.

Next, we discuss the vacuum isolating to problem 1.1 with $J\left(u_{0}\right)<d$.
Theorem 3.12. Let $e \in(0, d)$. Suppose $\delta_{1}, \delta_{2}$ are the two solutions of $d(\delta)=e$. Then for all weak solutions of problem (1.1) with $J\left(u_{0}\right) \leq e$, there is a vacuum region

such that there is no any weak solution of problem 1.1) in $U_{e}$.

Proof. Assume that $u(t)$ is any weak solution of problem 1.1 with $J\left(u_{0}\right) \leq$ $e, T_{\max }$ is the maximal existence time of $u(t)$. We only need to prove that if $\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \neq 0$ and $J\left(u_{0}\right) \leq e$, then for all $\delta \in\left(\delta_{1}, \delta_{2}\right)$, $u(t) \notin N_{\delta}$, i.e. $I_{\delta}(u(t)) \neq 0$, for all $t \in\left[0, T_{\max }\right)$.

At first, it is clear that $I_{\delta}\left(u_{0}\right) \neq 0$. Since if $I_{\delta}\left(u_{0}\right)=0$, then $J\left(u_{0}\right) \geq d(\delta)>$ $d\left(\delta_{1}\right)=d\left(\delta_{2}\right)$, which contradicts with $J\left(u_{0}\right) \leq e$.

Suppose there exists $t_{1}>0$ such that $u\left(t_{1}\right) \in U_{e}$. Namely, there must exist a $\delta_{0} \in\left(\delta_{1}, \delta_{2}\right)$ such that $u\left(t_{1}\right) \in N_{\delta_{0}}$. From the definition of $d(\delta)$, we get $J\left(u_{0}\right) \geq$ $J\left(u\left(t_{1}\right)\right) \geq d(\delta)>J\left(u_{0}\right)$, which leads to a contradiction.

## 4. Global solution and exponential decay

In this section, we prove the existence of global solutions by using the Galerkin approximation technique and the potential well theory. Meanwhile, we give an exponential decay result of the solution.

Theorem 4.1. Let $u_{0} \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})$. Assume that $E(0) \leq d$ and $I(u)>0$. Then problem (1.1) admits a global weak solution $u \in L^{\infty}\left(0, T ; \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})\right)$ with $\partial_{t} u \in$ $L^{\infty}\left(0, T ; \mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})\right) \cap \mathcal{L}_{2}^{\frac{n+1}{2}}\left(Q_{T}\right)$, where $Q_{T}=\mathbb{E} \times[0, T]$.
Proof. (1) Low initial energy case $(E(0)<d$ and $I(u)>0)$ : Let $\left\{\varphi_{j}\right\}$ be a sequence of orthogonal basis of $\mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})$, we introduce the following approximate solutions of problem 1.1):

From the definition of $d$, we have that $J\left(u_{m}\left(t_{0}\right)\right)>d$, which is contradiction. Thus for sufficiently large $m, u_{m}(t) \in W$ and $I\left(u_{m}\right)>0$. Then we obtain

(2) Critical initial energy case $(E(0)=d$ and $I(u)>0)$ : First $E(0)=d$ implies that $\left\|\nabla_{\mathbb{E}} u_{0}\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}{ }_{(\mathbb{E})}} \neq 0$. Pick a sequence $\lambda_{m}$ such that $0<\lambda_{m}<1, m=1,2, \ldots$ and $\lambda_{m} \rightarrow 1$ as $m \rightarrow \infty$. Let $u_{0 m}(x)=\lambda_{m} u_{0}(x)$, we consider the initial conditions

From the low initial case, it follows that for each $m$, problem (1.1) with 4.7) admits a global weak solution $u_{m} \in L^{\infty}\left(0, T ; \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})\right)$ with $\partial_{t} u_{m} \in L^{\infty}\left(0, T ; \mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})\right) \cap \mathcal{L}_{2}^{\frac{n+1}{2}}\left(Q_{T}\right)$, where $Q_{T}=\mathbb{E} \times[0, T]$ and $u_{m}(t) \in W$ for $0 \leq t<\infty$ satisfying

& =\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}\left|u_{m}\right|^{p_{k}} u \cdot v d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}\left|u_{m}\right|^{q_{j}} u \cdot v d \sigma, \quad \forall v \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E}),
\end{aligned}

for $t>0$, and

for $0 \leq t<\infty$. From 4.8 and

& \geq \frac{p-1}{2(p+1)}\left(1+C^{* 2}\right)\left\|\nabla_{\mathbb{E}} u_{m}\right\|_{\mathcal{L}_{2}^{2+1}(\mathbb{E})}^{2}
\end{aligned}

we get

The remainder of the proof is similar to the low initial case, then the proof is complete.

Theorem 4.2. Let $u_{0} \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E}), u_{0} \in W$ and $I(u)>0$, then there exist two positive constants $\widehat{C}$ and $\zeta$ independent of $t$ such that $0<E(t) \leq \widehat{C} e^{-\zeta t}$ for all $t \geq 0$.

To prove Theorem 4.2, we need the following lemma:
Lemma 4.3. Assume that $1<p<\frac{N+2}{N-2}$ and $N=n+h+1 \geq 3$, $u$ is the solution of problem 1.1 with

\end{equation*}
$$

then $u \in W$ on $[0, T]$.
Proof. Assume that there exists some time $T^{*}>0$ such that $u(t) \in W$, where $0 \leq t<T^{*}$ and $u\left(T^{*}\right) \in \partial W$, we can obtain $I\left(u\left(T^{*}\right)\right)=0$ and $u\left(T^{*}\right) \neq 0$. At the time $I\left(u\left(T^{*}\right)\right)=0$ and $u\left(T^{*}\right) \neq 0$, notice that

Then, by the energy identity $\int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})} d \tau+J(u)+\frac{1}{2} \int_{\mathbb{E}} \omega^{h}\left|\partial_{t} u\right|^{2} d \sigma \leq E(0)$, we have

& \leq \sum_{k=1}^{l} a_{k} C_{k}^{p_{1}+1}\left(\frac{2(p+1)}{p-1}\left(1+C^{* 2}\right)^{-1} E(0)\right)^{\frac{p_{1}-1}{2}}\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2}
\end{align*}
$$

which implies that $I\left(u\left(T^{*}\right)\right)>0$ for $t=T^{*}$. This completes the proof.

Proof of Theorem 4.2. From

\geq & \frac{1}{2} \int_{\mathbb{E}} \omega^{h}\left|\partial_{t} u\right|^{2} d \sigma+\left(\frac{1}{2}-\frac{1}{p+1}\right)\left(\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma\right) \\
& +\frac{1}{p+1} I(u),
\end{aligned}

we have $0<E(t)$ for all $t \geq 0$.
The proof of other inequality relies on the construction of a Lyapunov functional. And the Lyapunov functional is performed by a suitable modification of energy. For this purpose, let $\theta>0$, which will be chosen later, we define

& +\theta\left(-\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma-\int_{\mathbb{E}} \omega^{h}\left|u \partial_{t} u\right| d \sigma-\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma\right)  \tag{4.14}\\
& +\theta\left(\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}+1} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}+1} d \sigma\right) .
\end{align*}

Using Young inequality and Sobolev equality, for any $r>0$, we obtain

\end{aligned}

Inserting 4.15 into 4.14, we arrive at

& \left.\quad-\theta+\theta C^{2} r-\theta C^{2}\right)\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{n+1}}^{2}(\mathbb{E})
\end{aligned}
$$

By Lemma 4.3 we know $\sum_{k=1}^{l} a_{k} C_{k}^{p_{1}+1}\left(\frac{2(p+1)}{p-1}\left(1+C^{* 2}\right)^{-1} E(0)\right)^{\frac{p_{1}-1}{2}} \leq 1$. Then we choose $r<1$ such that

From this inequality we may find $\phi>0$, which depends only on $r$ such that

Consequently using the definition of the energy $E(t)$, for any suitable positive constant $M$, we obtain

## 5. Finite time blow-up of solution

In this section, we discuss the blow-up in finite time and seek a lower bound for the blow-up time $T^{*}$ for the solution of 1.1.
Theorem 5.1. Assume that $u$ is a local solution of problem 1.1), and $u_{0} \in$ $\mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E})$. If $I(u)<0$ and $E(0) \leq d$, and $\int_{\mathbb{E}} \omega^{h} u_{0} u_{1} d \sigma>0$ when $0 \leq E(0)<d$, where $d<\frac{p-1}{2(p+1)}\left(\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma\right)$ then the solution $u$ blows up in a finite time.

The following three lemmas will be used to prove Theorem 5.1.
Lemma 5.2. Let $u$ be the unique local solution of problem 1.1 and assume that $u$ satisfy $E(0) \leq d$, one has $I(u)<0$ and

d & <\frac{p-1}{2(p+1)}\left(\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma\right) \\
& <\frac{p-1}{2(p+1)}\left(\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}+1} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}+1} d \sigma\right)
\end{aligned}
$$

for all $t \in\left[0, T_{\text {Max }}\right)$.
Proof. Since $I(u)<0$ for all $0 \leq t<T^{*}$, it follows that

For all $0 \leq t<T^{*}$, using the definition of $d$, we get

By the continuity of $t \mapsto \sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}+1} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}+1} d \sigma$ we get $u\left(T^{*}\right) \neq 0$. From the definition of $J(u)$, we obtain

d \leq \frac{p-1}{2(p+1)}\left(\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}\left|u\left(T^{*}\right)\right|^{p_{k}+1} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}\left|u\left(T^{*}\right)\right|^{q_{j}+1} d \sigma\right)=J\left(u\left(T^{*}\right)\right)
$$

which contradicts to $J\left(u\left(T^{*}\right) \leq E\left(T^{*}\right)<d\right.$. Then, we obtain

d & <\frac{p-1}{2(p+1)}\left(\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma+\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma\right) \\
& <\frac{p-1}{2(p+1)}\left(\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}+1} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}+1} d \sigma\right)
\end{aligned}
$$

Lemma 5.3. Assume $M(t)>0$ is a twice differentiable function, then the inequality

holds for $t>0$ and $\alpha>0$. If $M(0)>0$ and $M^{\prime}(0)>0$, then there exists a time $T^{*} \leq \frac{M(0)}{\alpha M^{\prime}(0)}$ such that $\lim _{t \rightarrow T^{*-}} M(t)=\infty$.

Proof of Theorem 5.1. We consider $M:[0, T] \rightarrow R_{+}$defined by

& =2 \int_{\mathbb{E}} u \partial_{t} u d x+2 \int_{0}^{1}\left(u(\tau), \partial_{t} u(\tau)\right)_{2} d \tau+2 \kappa\left(t+T_{0}\right)
\end{align*}
$$

and consequently,

\begin{aligned}
M^{\prime \prime}(t) & =2\left(\partial_{t t} u, u\right)+2\left\|\partial_{t} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}}^{2}+2\left(\partial_{t} u, u\right)+2 \kappa \\
& =2\left[-\left\|\nabla_{\mathbb{E})} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2}-\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma+\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}+1} d \sigma\right] \\
& -2\left[\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}+1} d \sigma-\left\|\partial_{t} u\right\|_{\mathcal{L}_{2}^{n+1}}^{2}-\kappa\right] .
\end{aligned}
$$

For almost every $t \in[0, T]$, we get

$$
\left.\left.\begin{array}{l}
M(t) M^{\prime \prime}(t)-\frac{p+3}{4} M^{\prime}(t)^{2} \\
=M(t) M^{\prime \prime}(t)+(p+3)\left[\eta(t)-\left(M(t)-(T-t)\left\|u_{0}\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2}\right)\right. \\
\quad \times\left(\left\|\partial_{t} u\right\|_{\mathcal{L}_{2}^{2+1}}^{2}+\int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{n}}^{2}(\mathbb{E})\right.
\end{array} d \tau+\kappa\right)\right], ~ l
$$

where $\eta:[0, T] \rightarrow R_{+}$is the function defined by

$$
\begin{aligned}
\eta(t)= & \left(\|u\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}}^{2}+\int_{0}^{t}\|u(\tau)\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2} d \tau+\kappa\left(t+T_{0}\right)^{2}\right) \\
& \times\left(\left\|\partial_{t} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2}+\int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2} d \tau+\kappa\right) \\
& -\left(\int_{\mathbb{E}} \omega^{h} u \partial_{t} u d \sigma+\int_{0}^{t}\left(u, \partial_{t} u\right)_{2} d \tau+\kappa\left(t+T_{0}\right)\right)^{2} \geq 0
\end{aligned}
$$

As a consequence, we have differential equality

$$
\begin{equation*}
M(t) M^{\prime \prime}(t)-\frac{p+3}{4} M^{\prime}(t)^{2} \geq M(t) \xi(t) \tag{5.4}
\end{equation*}
$$

For almost every $t \in[0, T], \xi:[0, T] \rightarrow \mathbb{R}_{+}$is the map defined by

$$
\begin{aligned}
& \xi(t)=M^{\prime \prime}(t)+\left(\left\|\partial_{t} u\right\|_{\mathcal{L}_{2}^{2}(\mathbb{E})}^{2}+\int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{2}}^{2}{ }_{(\mathbb{E})}^{\frac{n+1}{}} d \tau+\kappa\right)(p+3) \\
& =2\left[-\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{2}}^{2}{ }_{(\mathbb{E})}-\int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma+\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}+1} d \sigma\right] \\
& -2\left[\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}+1} d \sigma-\left\|\partial_{t} u\right\|_{\mathcal{L}_{2}^{2}}^{2}{ }_{(\mathbb{E})}-\kappa\right] \\
& -(p+3)\left(\left\|\partial_{t} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2}+\int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2} d \tau+\kappa\right) \\
& \geq-2(p+1) E(t)+(p-1)\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2}+(p-1) \int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \\
& -(p+3) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}{ }_{(\mathbb{E})}^{2}} d \tau-(p+1) \kappa \\
& =-2(p+1) E(0)+(p-1)\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}{ }_{(\mathbb{E})}^{2}}+(p-1) \int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \\
& +(p-1) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{n+1}}^{2} d \tau-(p+1) \kappa .
\end{aligned}
$$

Case 1. If $E(0)<0$, then

$$
\begin{aligned}
\xi(t)= & -2(p+1) E(0)+(p-1)\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{n+1}(\mathbb{E})}^{2}+(p-1) \int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \\
& +(p-1) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{2}}^{2}{ }^{\frac{n+1}{2}}(\mathbb{E}) \\
\geq & -2(p-1) E(0)+(p-1)\left(1+C^{* 2}\right)\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}}^{2}{ }^{\frac{n+1}{2}(\mathbb{E})} \\
& +(p-1) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2} d \tau-(p+1) \kappa .
\end{aligned}
$$

Choosing $\kappa$ satisfying $\kappa \leq-2 E(0)$, we have

$$
\begin{equation*}
\xi(t) \geq(p-1)\left(1+C^{* 2}\right)\left\|\nabla_{E} u\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2}+(p-1) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2} d \tau \geq 0 \tag{5.5}
\end{equation*}
$$

Case 2. If $0 \leq E(0)<d$, then by Lemma 5.2, we have

$$
\begin{aligned}
\xi(t)= & -2(p+1) E(0)+(p-1)\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{n+1}(\mathbb{E})}^{2}+(p-1) \int_{\mathbb{E}} \omega^{h} V|u|^{2} d \sigma \\
& +(p-1) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{2}(\mathbb{E})}^{2} d \tau-(p+1) \kappa \\
= & 2(p+1)(d-E(0))+(p-1) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{2}}^{2}{ }_{(\mathbb{E})}^{\frac{n+1}{2}} d \tau-(p+1) \kappa \\
\geq & (p-1) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{2}}^{2}{ }_{(\mathbb{E})}^{n+1} d \tau-(p+1) \kappa .
\end{aligned}
$$

Choosing $\kappa=0$, we have $(p-1) \int_{0}^{t}\left\|\partial_{t} u(\tau)\right\|_{\mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E})}^{2} d \tau \geq 0$. Then we obtain

$$
\begin{equation*}
\xi(t) \geq 0 . \tag{5.6}
\end{equation*}
$$

Therefore, from (5.4) 5.5 and 5.6, we obtain

$$
M(t) M^{\prime \prime}(t)-\frac{p+3}{4} M^{\prime}(t)^{2} \geq 0
$$

By Lemma 5.3 and 5.3 , for every $t \in[0, T]$, if $E(0)<0$, we then choose $T_{0}$ sufficiently large such that $M^{\prime}(0)=2 \int_{\mathbb{E}} \omega^{h} u_{0} u_{1} d \sigma+2 b T_{0}>0$; if $0 \leq E(0)<d$, the condition $\int_{\mathbb{E}} \omega^{h} u_{0} u_{1} d \sigma>0$ also ensure that $M^{\prime}(0)>0$. As $\frac{p+3}{4}>1$, letting $\alpha=\frac{p-1}{4}$, we get $\lim _{t \rightarrow T^{*-}} M(t)=\infty$ by the convexity argument, which implies that $\lim _{t \rightarrow T^{*-}}\left\|\nabla_{\mathbb{E}} u\right\|_{\mathcal{L}_{2}^{2 n+1}(\mathbb{E})}^{2}=\infty$.

Theorem 5.4. Assume that

$$
1<p \leq \frac{N}{N-2}, \quad N \geq 3, \quad u_{0} \in \mathcal{H}_{2,0}^{1, \frac{n+1}{2}}(\mathbb{E}), \quad u_{1} \in \mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E}), \quad E(0)<0
$$

Then the solution blows up at time $T^{*}$.
Proof. We define the auxiliary function

$$
\Phi(t):=\int_{\mathbb{E}} \omega^{h}\left(u_{t}^{2}+\left|\nabla_{\mathbb{E}} u\right|^{2}+V u^{2}\right) d \sigma
$$

Differentiating $\Phi(t)$ and making use of the divergence theorem, we obtain

$$
\begin{align*}
\Phi^{\prime}(t) & =2 \int_{\mathbb{E}} \omega^{h}\left(u_{t} u_{t t}+\left|\nabla_{\mathbb{E}} u\right|\left|\nabla_{\mathbb{E}} u_{t}\right|+V u u_{t}\right) d \sigma \\
& =2 \int_{\mathbb{E}} \omega^{h} u_{t}\left(u_{t t}+\left|\Delta_{\mathbb{E}} u\right|+V u\right) d \sigma  \tag{5.7}\\
& =2\left(\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}} u_{t} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}} u_{t} d \sigma-\int_{\mathbb{E}} \omega^{h}\left|u_{t}\right|^{2} d \sigma\right) .
\end{align*}
$$

The two terms on the right-hand side of (5.7) can be estimated as follows

$$
\begin{aligned}
\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}} d \sigma & \leq \sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}} d \sigma \\
& \leq \sum_{k=1}^{l} a_{k} C_{k}^{p_{k}}\left\|\nabla_{\mathbb{E}} u\right\|^{p_{k}} \mathcal{L}_{2}^{\frac{n+1}{2}}(\mathbb{E}) \\
& \leq C\left(\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma\right)^{p_{1}}
\end{aligned}
$$

Then, we have

$$
\begin{aligned}
& 2\left(\sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}} u_{t} d \sigma-\sum_{j=1}^{s} b_{j} \int_{\mathbb{E}} \omega^{h}|u|^{q_{j}} u_{t} d \sigma\right) \\
& \leq 2 \sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{p_{k}} u_{t} d \sigma
\end{aligned}
$$

$$
\begin{aligned}
& \leq 2\left(\int_{\mathbb{E}} \omega^{h} u_{t}^{2} d \sigma \sum_{k=1}^{l} a_{k} \int_{\mathbb{E}} \omega^{h}|u|^{2 p_{k}} d \sigma\right)^{1 / 2} \\
& \leq 2 \sqrt{C}\left(\int_{\mathbb{E}} \omega^{h} u_{t}^{2} d \sigma\right)^{1 / 2}\left(\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma\right)^{p_{1} / 2} \\
& \leq \sqrt{C}\left\{\int_{\mathbb{E}} \omega^{h} u_{t}^{2} d \sigma+\left(\int_{\mathbb{E}} \omega^{h}\left|\nabla_{\mathbb{E}} u\right|^{2} d \sigma\right)^{p_{1}}\right\} \leq \sqrt{C}\left(\Phi+\Phi^{p_{1}}\right),
\end{aligned}
$$

which leads to the differential inequality

$$
\Phi^{\prime}(t) \leq \alpha \Phi+\beta \Phi^{p_{1}}
$$

where $\alpha=\beta=\sqrt{C}$. This differential inequality may be reduced to a linear differential inequality for $v(t):=\Phi^{1-p_{1}}$. Integrating this inequality, we obtain

$$
\begin{equation*}
(\Phi(t))^{1-p_{1}} \geq\left\{(\Phi(0))^{1-p_{1}}+1\right\} e^{-\left(p_{1}-1\right) \sqrt{C} t}-1 \tag{5.8}
\end{equation*}
$$

It follows from (5.8), that $\Phi(t)$ remains bounded for $t \in[0, T)$ with

$$
T^{*}=\frac{1}{\left(p_{1}-1\right) \sqrt{C}} \log \left\{1+(\Phi(0))^{1-p_{1}}\right\}
$$

It gives that $T^{*}$ is a lower bound for the blow-up time.
